3. **L16-464 - Caddo Parish, Fire District No. 1** - 14.0 mills tax, 10 years, 2018-2027, (1) purchasing fire trucks and other fire protection equipment, (2) acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment, (3) paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and services and (4) salaries of firemen.
4. **L16-468 - Evangeline Parish, City of Ville Platte** - 9.76 mills tax, 15 years, 2017-2031, (1) maintaining and improving public streets, sidewalks and alleys and (2) constructing, improving and maintaining drains and drainage facilities.
